Dear Speaker Johnson,

We write to you with an urgent and unequivocal call to action. Like you, we believe the disgraceful act of political violence that occurred at a recent Donald Trump campaign rally has no place in this country and should be unanimously and forcefully condemned. Political violence like the attempted assassination of former President Donald Trump with an AR-15 assault rifle will continue unless we curb the means of political violence. The House of Representatives must take decisive and resolute action to bring H.R. 698, the Assault Weapons Ban of 2023 and H.R. 8600, the Gas-Operated Semi-Automatic Firearms Exlusion (GOSAFE) Act to a vote.

We recognize the importance of the President's messages of unity,<sup>3</sup> and the House of Representatives must do its part. Messages alone will not stop the next assailant. An assault weapons ban, or gas-operated weapons ban could have helped prevent the attack that cost an American his life. As elected representatives, we have the chance to bring H.R. 689 introduced by Representative Lucy McBath to the House floor for a vote. This critical piece of legislation seeks to reinstate the prohibition on assault weapons, a measure proven to save lives. We also have the chance to bring H.R. 8600 to the floor for a vote. This piece of legislation will prohibit gas-operated firearms such as the firearm used in this past weekend. The evidence irrefutably shows that during the period when the federal assault weapons ban was in place, mass shootings decreased significantly.<sup>4</sup> Since its expiration in 2004, the data shows an almost immediate – and steep – rise in mass shooting deaths in the years after the assault weapons ban.<sup>5</sup>

What we saw on July 14, 2024, is that the need to act against political violence is not a partisan issue, it is a matter of public safety and common sense. It should not take the attempted assassination of a former President for the Speaker of the House to act. A failure to respond in the face of a brazen, attack almost certainly invites a future tragedy.

Time and time again, assault weapons have been the weapon of choice for those perpetrating political violence. In the 2016 Pulse Nightclub Shooting, 49 people were killed and 53 others were injured;<sup>6</sup> in the 2017 Congressional Baseball Game Shooting, now Majority Leader Steve Scalise was shot and three others injured;<sup>7</sup> in the 2018 Pittsburgh Synagogue Shooting, 11 people were killed and 6 injured;<sup>8</sup> in the 2019 El Paso Walmart and Dayton Shootings, 32 total people were killed and 40 more were injured;<sup>9</sup> in the 2022 Buffalo and Uvalde Shootings, 29 people were killed, including 19 children.<sup>10</sup> Now there has been an attempt on the life of a presidential candidate, which led to at least one other death.<sup>11</sup>

The assault weapons used in these attacks were designed for war and enable a lone attacker to inflict mass casualties in mere moments. These assault weapons have no place on our streets. The American people overwhelmingly support the reinstatement of the assault weapons ban. A recent survey found that a significant majority of Americans, including gun owners, favor such legislation. <sup>12</sup> The time for thoughts and prayers has long passed; now is the time for action.

We urge you, Speaker Johnson, to demonstrate true leadership and moral courage by bringing H.R. 698, the Assault Weapons Ban of 2023 and H.R. 8600, the GOSAFE Act to the floor for an immediate vote. The lives of countless Americans depend on our ability to act decisively and responsibly. The legacy of
